Performance: Up to a 30 minute show (inside or outside)

Space required: 5.5m square clear floor space (against a wall ideally), ceiling height must be 5m (beware of chandeliers) **Sound requirements:** The acts provides all sound equipment built into top hat stage (for music and two headsets microphones)

Lighting requirements: Client to provide a good colour wash over the performance area, Firebird Events can provide this from £POA

Top Hat act performance cost: £POA

Stage Show Act

Performance: 12-30 minute show (inside)


Space required: 6m wide x 5m dee x 2.5m height

Sound requirements: The act provides two headsets microphones, client to provide a good quality recognised sound system and a sound engineer. Firebird Events can provide this from £POA
